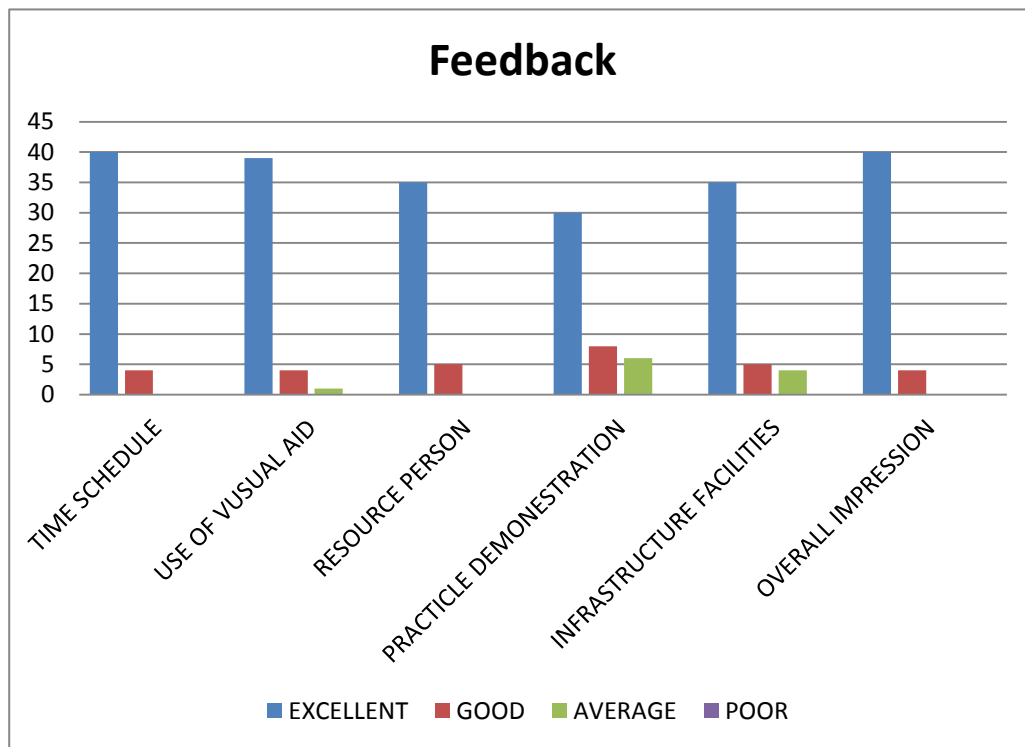

This Memorandum of Understanding (hereinafter referred to as the "MOU") is made and executed on this (Date) 04

(hereinafter referred to as "PARTNER INSTITUTE")

AND

BAJAJ FINSERV LIMITED, a company registered under the provisions of the Companies Act, 1956, having its registered office at: Bajaj Auto Ltd Complex, Mumbai-Pune Road, Pune 411 035

AND

BAJAJ FINANCE LIMITED, a company registered under the provisions of the Companies Act, 1956, having its registered office at: Akurdi, Pune 411 035

Through President (Legal and Taxation) – Bajaj Finserv Limited

(Bajaj Finserv Limited and Bajaj Finance Limited hereinafter referred to as "FINSERV")

The expressions "PARTNER INSTITUTE" and "FINSERV" shall, collectively be referred to as "Parties" and individually as "Party".

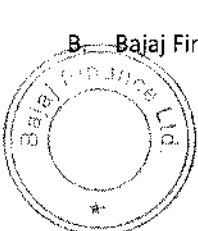
WHEREAS:


A. PARTNER INSTITUTE established in (Year) 1961 by (Educational Society/Trust)

B. Bajaj Finserv Limited is the holding company for financial services businesses of the Bajaj Group;

- C. Bajaj Finance Limited is a Non-Banking Finance Company registered with Reserve Bank of India.
- D. FINSERV, as part of its Corporate Social Responsibility (CSR) activities, desires to create employment opportunities for educated youth in the Banking, Finance and Insurance Sector through a customized training programme encompassing product knowledge, communication and other soft skills, which is expected to benefit fresh graduates, especially those belonging to economically weaker sections of the society;
- E. FINSERV, in partnership with some of the leading educational institutes, has designed and developed a customized programme viz. Certificate Programme in Banking, Finance and Insurance (hereinafter referred to as CPBFI).
- E. The PARTNER INSTITUTE has expressed its willingness to partner with FINSERV to conduct CPBFI for its students and alumni, on terms and conditions set out herein below;
- F. FINSERV has accepted the offer of the PARTNER INSTITUTE and agreed to partner with the PARTNER INSTITUTE for conducting CPBFI, on terms and conditions set out below.

NOW THIS AGREEMENT WITNESSETH AND IT IS AGREED BY AND BETWEEN THE PARTIES AS UNDER:

1. Purpose/Objective of CPBFI:

The objective of CPBFI is to impart practical knowledge and essential skills to final year graduation students and fresh graduates, especially those belonging to economically weaker sections of the society, with a view to create employment opportunities for them in the Banking, Finance and Insurance Companies.


2. Scope of CPBFI:

- i. FINSERV has appointed different training institutes as Official Training Partners for conducting CPBFI (hereinafter referred to as CPBFI Official Training Partners).
- ii. FINSERV and the PARTNER INSTITUTE, through one of the CPBFI Official Training Partners, shall conduct, for the eligible students and alumni of the PARTNER INSTITUTE, a Certificate Programme in Banking, Finance and Insurance viz. CPBFI, covering industry overview and product knowledge relevant for roles in banks, NBFCs, life insurance and general insurance companies, communication and other workplace skills. CPBFI shall be conducted through classroom training (hereinafter referred to as CPBFI-CLASSROOM), online training (hereinafter referred to as CPBFI-ONLINE) or a combination of classroom and online training (hereinafter referred to as CPBFI-BLENDED).

3. Responsibilities of the Parties:

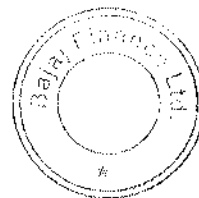
- i. The PARTNER INSTITUTE shall be responsible for mobilizing students for the CPBFI Programme by spreading awareness about CPBFI and its potential benefits for the prospective students. FINSERV shall, if requested by PARTNER INSTITUTE, at its discretion, support the awareness campaigns by participating in the student meetings, parent meetings and design of publicity material such as posters, leaflets etc.
- ii. The PARTNER INSTITUTE shall be responsible for providing necessary infrastructure facilities for conducting classroom sessions of CPBFI-CLASSROOM and CPBFI-BLENDED, specifically (a) one class room, equipped with a projector, a sound system and a white-board with a seating capacity of at least 45 students, (b) one computer room, equipped with computers having MS Office software and high-speed internet connection, with a seating

capacity of at least 25 students, for conducting the online assessment tests (c) one assembly hall with a capacity of around 60 persons and 3 interview rooms, for one day per batch, for conducting CPBFI HR Workshop. PARTNER INSTITUTE shall also provide basic stationery required for training purposes such as marker pens, chart sheets, chalks etc.

- iii. The PARTNER INSTITUTE shall appoint a Coordinator for every CPBFI batch, with following responsibilities.
 - a. To motivate and encourage students to extract maximum benefit from CPBFI.
 - b. To provide necessary support to the CPBFI Official Training Partner for planning and conducting the program.
 - c. To conduct online pre-assessment and post-assessment tests for every batch.
 - d. To ensure that the classes are conducted as per pre-defined schedule.
 - e. To ensure that all students are regularly attending the classes.
 - f. To maintain daily attendance of students.
 - g. To attend few classes as an observer and provide feedback to FINSERV about the training quality.
 - h. To ensure discipline and good conduct from the students.
 - i. To support FINSERV team to conduct CPBFI HR Workshop for every batch.
 - j. To submit required college information as per Annexure 3 to FINSERV coordinator.
- iv. The PARTNER INSTITUTE shall issue an appointment letter to the Coordinator as per format prescribed in Annexure 4 of this MOU. The PARTNER INSTITUTE shall submit the appointment letter, duly authorized by the Principal of the PARTNER INSTITUTE and accepted by the Coordinator, to FINSERV before commencement of every CPBFI Batch.
- v. FINSERV shall be responsible to design and continuously improve the CPBFI programme structure, including adding or deleting courses, changing pedagogy or modifications to the programme duration.
- vi. FINSERV shall be responsible to arrange faculty, with requisite expertise and experience, through any of its CPBFI Official Training Partners. FINSERV shall provide necessary details of the concerned CPBFI Official Training Partner to the PARTNER INSTITUTE at least 2 weeks before start of every batch. FINSERV shall be responsible to arrange the online training platform for conducting CPBFI-ONLINE and CPBFI-BLENDED.
- vii. FINSERV and the PARTNER INSTITUTE, shall be responsible for award of "Certificate of Completion" at the completion of CPBFI to all successful candidates who meet eligibility criteria viz. requisite attendance and credits in the examinations conducted during CPBFI.
- viii. FINSERV, as part of its CSR, shall bear the full cost of faculty deployed by its CPBFI Official Training Partner, to ensure that CPBFI is affordable to students belonging to economically weaker sections of the society.
- ix. FINSERV along with its chosen academic partner/s, shall conduct an online examination at the end of CPBFI. Only students who pass this examination and have requisite attendance shall be eligible to receive the "Certificate of Completion". This examination shall be in addition to all other examinations conducted by the CPBFI Official Training Partner during CPBFI.
- x. The PARTNER INSTITUTE shall display the FINSERV name and logo prominently in all marketing and publicity material, notices for students and all other internal and external communications, in paper form or otherwise, relating to CPBFI.
- xi. Any other use of FINSERV brand names by the PARTNER INSTITUTE shall require prior written consent from FINSERV.



- xii. The PARTNER INSTITUTE shall provide to FINSERV, necessary information about all the students of CPBFI, in the format specified by FINSERV in Annexure 1. FINSERV shall be free to contact the students directly for the purpose of monitoring the impact of CPBFI and the career progression of students.
- xiii. The PARTNER INSTITUTE shall not conduct CPBFI or a programme with identical course structure except in partnership with FINSERV.
- xiv. The PARTNER INSTITUTE shall be solely responsible to comply with regulations of University Grants Commission or any other authority regulating educational activities in India. The PARTNER INSTITUTE agrees that FINSERV shall not have any liability including monetary or otherwise, in the event of any regulatory action taken against the PARTNER INSTITUTE in respect of conducting this programme. The PARTNER INSTITUTE agrees to fully compensate FINSERV in case an action is taken against FINSERV by any such regulatory authority in respect of conduct of CPBFI by the PARTNER INSTITUTE under this MOU.
- xv. The PARTNER INSTITUTE shall be solely responsible for payment of GST or any other taxes that may be applicable, in respect of fees collected by the PARTNER INSTITUTE for CPBFI and FINSERV shall not have any liability towards the same. The PARTNER INSTITUTE agrees that FINSERV shall not have any liability, monetary or otherwise, in the event of any action is taken against the PARTNER INSTITUTE by any tax authorities. The PARTNER INSTITUTE agrees to fully compensate FINSERV in case any action is taken against FINSERV by any such tax authority in respect of conduct of CPBFI by the PARTNER INSTITUTE under this MOU.
- xvi. The PARTNER INSTITUTE shall submit the information specified in Annexure 3 before commencement of every batch to FINSERV.

4. Batch Strength:

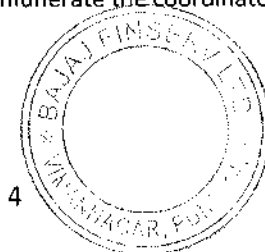
The parties agree that, each batch shall consist of minimum 45 and maximum 60 students. FINSERV and the PARTNER INSTITUTE may mutually decide to start a batch with less than 45 students.

5. Term of the MOU:

The term of this MOU is for a period commencing from signing of this MoU till end of March 31, 2024, except Clause 3(xiii) and Clause 14, which shall continue to be in force for a further period of 3 years from the date of termination of this MOU. The parties may decide to further extend the term of this MOU by mutual consent on such terms and conditions as may be agreed between them.

6. Course fees:

- i. PARTNER INSTITUTE shall charge a non-refundable fee of (In figures) Rs. 1000 Fees in words) Rupees One thousand only only plus applicable GST and other taxes, to each of the students of CPBFI towards the course fees. The fee payable by each student shall not be less than Rs. 1,000 (Rupees one thousand only) plus applicable taxes and shall not exceed Rs. 3,000 (Rupees three thousand) plus applicable taxes. The fees specified here shall be valid for two years from signing of this MOU. The fees shall be reviewed on completion of this period and parties may mutually agree to revise the same from time to time.
- ii. The PARTNER INSTITUTE has agreed to suitably remunerate the coordinator and other staff members for their effort towards successful conduct of CPBFI Batch.

- iii. The PARTNER INSTITUTE, may at its own discretion, waive the fees of students from economically weaker sections, provided the number of such students does not exceed 15% of total enrolment in the respective batch.
- iv. The PARTNER INSTITUTE shall ensure that no student shall be allowed to attend CPBFI without paying the full fees except those permitted under sub-clause iv above.
- v. The PARTNER INSTITUTE shall submit to FINSERV, before commencement of any batch, extracts of bank statement or copies of cash receipts or a letter from the Principal or Vice-Principal confirming collection of fees from every participant.

7. Duration and contents of CPBFI:

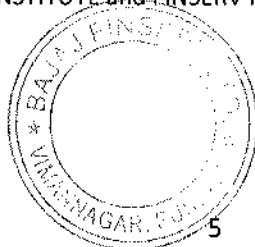
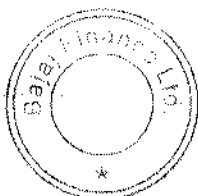
- i. CPBFI shall commence from (Month and Year) January 2024. The said Programme will involve training of about 100 hours.
- ii. The PARTNER INSTITUTE has agreed to mobilize, on best effort basis, at least 40 students in first academic year and at least 80 students from second academic year onwards. The PARTNER INSTITUTE shall decide the batch schedule and timings and inform the schedule to FINSERV at least 45 days before commencement of the batch.
- iii. FINSERV shall arrange to make the faculty available as per the schedule informed by the PARTNER INSTITUTE.
- iv. Detailed schedule of the lectures and practical shall be given in advance to students before commencement of CPBFI.

8. Place of teaching:

- i. The CPBFI classroom teaching and practical shall be conducted at (College Name and City) Nabira Mahavidyalaya Katoj
by the CPBFI Official Training Partner, for up to four hours a day on such days, dates and at such timings as may be mutually decided between the parties.

9. Eligibility for CPBFI:

- i. Any student who is studying in the final year of Graduation Programme or pursuing any post-graduation programme shall be eligible to apply for admission to CPBFI.
- ii. Additionally, any fresh graduate i.e. a graduate with less than 2 years of work experience or no work experience, shall also be eligible to apply for admission to CPBFI.
- iii. Only candidates who are less than 27 years old, on the date of application, are eligible to apply for admission to CPBFI.
- iv. The PARTNER INSTITUTE shall select the final list of candidates for admission based on the criteria mutually agreed upon by the PARTNER INSTITUTE and FINSERV from time to time.

10. Discipline and right to expel:

- i. The students of CPBFI-CLASSROOM and CPBFI-BLENDED shall be subject to rules of discipline/code of conduct of the PARTNER INSTITUTE during course period. In case of CPBFI – ONLINE, the students shall be subject to rules of discipline/code of conduct of the CPBFI Official Training Partner.
- ii. If the concerned CPBFI Official Training Partner observes a breach of code of conduct by any student, it shall immediately report the same to the CPBFI Coordinator for necessary action.
- iii. If any participant commits breach of code of conduct of the PARTNER INSTITUTE, the faculty shall have full authority to expel such student for the remaining duration of CPBFI.

11. Faculty:

- i. FINSERV shall be solely responsible for arranging, through a CPBFI Official Training Partner, faculty, with requisite industry and teaching experience, and conducting CPBFI efficiently and effectively. The PARTNER INSTITUTE shall not be responsible for making any payments to the faculty of the CPBFI Official Training Partner.
- ii. Some of the lectures of CPBFI may be conducted by the experts from FINSERV as per the understanding between the parties. However, the PARTNER INSTITUTE shall not be liable to pay any amounts to FINSERV towards the said lectures and no amounts shall be deducted from the amounts payable to the PARTNER INSTITUTE.

12. Certification:

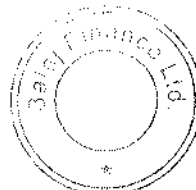
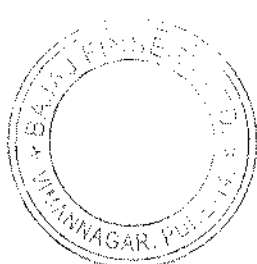
FINSERV and the PARTNER INSTITUTE shall issue a "Certificate of Completion" in "Certificate Programme in Banking, Finance and Insurance" to the eligible students of CPBFI-CLASSROOM, CPBFI-ONLINE and CPBFI-BLENDED. The certificates shall be designed and printed by FINSERV and shall carry the names of the PARTNER INSTITUTE and the concerned CPBFI Official Training Partner.

13. Further Agreements:

The parties agree that, they may mutually discuss and enter into further agreements, if needed.

14. Confidentiality:

- i. The Parties agree to maintain strict secrecy and confidentiality regarding any and all Confidential Information exchanged or to be exchanged between them in relation to this MOU.
- ii. The PARTNER INSTITUTE agrees that all the course material provided by FINSERV or the CPBFI Official Training Partner, including but not limited to CPBFI structure, curriculum, lesson plans and evaluation methods, shall be deemed to be Confidential Information.
- iii. The PARTNER INSTITUTE agrees that any of FINSERV's technical or business or other information including information given for development of any case studies / development of any program modules / contents, made available by FINSERV or its personnel to the PARTNER INSTITUTE shall be deemed to be Confidential Information.

- iv. The PARTNER INSTITUTE agrees to restrict access and disclosure of Confidential Information to such of their employees, agents, vendors, and contractors strictly on a "need to know" basis, to maintain confidentiality of the Information disclosed to it in accordance with this clause.
- v. Information and material disclosed and provided by each party to the other party in pursuance of or in connection with performance of its obligation under this MOU shall, at all times, remain the sole and exclusive property of the disclosing Party.

15. Intimation about cancellation/postponement of CPBFI:

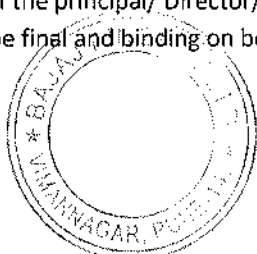
- i. If due to any cogent reasons, it appears to the PARTNER INSTITUTE that it is unable to arrange any batch as per schedule, the PARTNER INSTITUTE shall intimate about its inability to FINSERV at least 30 days in advance and the parties shall decide further schedule of CPBFI by mutual consent. FINSERV may decide to complete such batches through online classes.
- ii. However, if such postponement or cancellation is necessitated due to any last minute, unforeseen and unavoidable circumstances like Act of God, civil commotion, strike, bandh, disruption of traffic, epidemic, war, aggression, change in Government Policy or any other similar circumstances, the PARTNER INSTITUTE shall intimate the change in schedule as early as possible after such circumstances as stated above have arisen. In such circumstances, the PARTNER INSTITUTE shall not be held liable for payment towards any loss or damages caused to FINSERV due to delay in its schedule.
- iii. If for any reason, FINSERV, decides to discontinue support for CPBFI, it shall give a written notice to the PARTNER INSTITUTE, 30 days in advance. Such notice shall not impact any batch which is already in progress on the date of notice and the terms of this MOU shall continue to apply to the running batches.

16. Amendment/Termination:

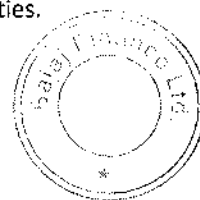
- i. Any amendment to the terms of this MOU can only be made by mutual consent of the parties.
- ii. This MOU may be terminated by either party, for breach of terms and conditions of the present MOU or otherwise, by a written notice of at least one (1) month in advance. Such notice of termination shall not interfere with the batches underway at the relevant time. Such batches shall be allowed to continue until their conclusion.
- iii. Both the parties agree that Finserv shall have the right of terminating this MOU without any notice to the PARTNER INSTITUTE, if the PARTNER INSTITUTE charges a fee exceeding the amount prescribed under Clause 6(i) of this MOU. In such event, the batches underway at the relevant time, may also be terminated by FINSERV, unless the PARTNER INSTITUTE refunds the excess fee charged to every student of the batch.

17. Applicable Law and Dispute Settlement:

- i. This MOU shall be governed by the Laws of India.
- ii. Any dispute arising between the parties in connection with or arising out of the performance of mutual obligations under this MOU shall be resolved by mutual discussion and consultation. If the dispute remained unresolved even after 30 days, then the dispute shall be referred to the Principal/ Director/ Vice Chancellor/ Registrar/Dean of PARTNER INSTITUTE and Mr. V. Rajagopalan, President (Legal and Taxation), Bajaj Finserv Limited. The decision of the principal/ Director/ Vice Chancellor/ Registrar/Dean of PARTNER INSTITUTE and Mr. Rajagopalan shall be final and binding on both parties.

Annexure 2: Methodology for Calculating Overall Attendance of the Batch

The steps and formula for calculating overall attendance are as under.

1. Enrollment: Number of students who have registered and paid fees for CPBFI
2. Drop-outs: Number of students who stopped attending CPBFI during the batch
3. Regular students: Enrollment minus Drop Out
4. Total available student days: Number of regular students multiplied by total duration of CPBFI (number of days. E.g. 40 days)
5. Actual student days: Sum of days attended by each regular student.
6. Overall attendance (%) = Actual Student Days / Available Student Days X 100

Example: In a CPBFI batch 43 students registered and paid fees. By end of first week 3 students stopped attending the batch. The batch was conducted for 40 days. Out of the 40 regular students – 10 attended every class, 15 attended for 35 days, 10 attended for 33 days and 5 attended by 30 days. Overall attendance will be calculated as under.

Enrollment: 43

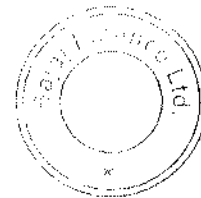
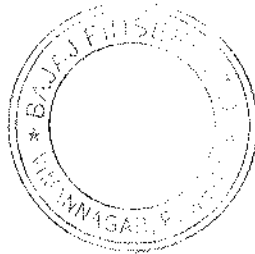

Regular students: 40

Available days: 40 X 40 i.e. 1600

Actual days: (10 X 40) + (15 X 35) + (10 X 33) + (5 X 30) = 400 + 525 + 330 + 150 = 1405

Overall attendance: (1405 / 1600) X 100 = 87.81%

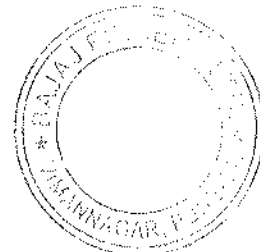





NABIRA MAHAVIDYALAYA may depute faculty to be members of such committees. 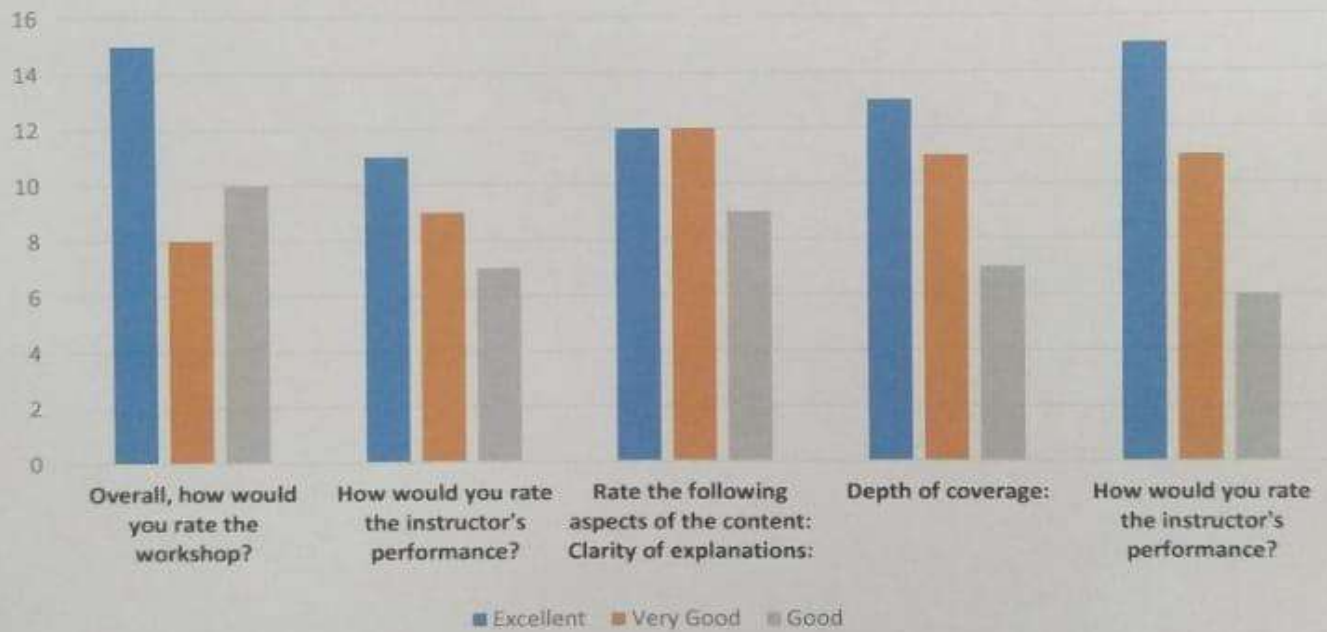

Hematology CBC Counting

Introduction

A complete blood count (CBC), also known as a full blood count (FBC), is a set of medical laboratory tests that provide information about the cells in a person's blood. The CBC indicates the counts of white blood cells, red blood cells and platelets, the concentration of hemoglobin, and the hematocrit (the volume percentage of red blood cells). The red blood cell indices, which indicate the average size and hemoglobin content of red blood cells, are also reported, and a white blood cell differential, which counts the different types of white blood cells, may be included.

Complete blood count (CBC) test is one of the most common and important blood tests that measures the number and characteristics of different types of cells in the blood, such as red blood cells, white blood cells, and platelets. CBC test can help diagnose and monitor various diseases and conditions, such as anemia, infection, inflammation, bleeding, and cancer. we will explore the history of CBC test from its origins in the 19th century to its modern developments in the 21st century.

The first person to publish microscopic observations of blood cells was Antonie van Leeuwenhoek, who reported on the appearance of red cells in a 1674 letter to the Proceedings of the Royal Society of London. The physiologist Karl Vierordt is credited with performing the first blood count. His technique, published in 1852, In the 1870s, Paul Ehrlich developed a staining technique using a combination of an acidic and basic dye that could distinguish different types of white blood cells and allow red blood cell morphology to be examined. Dmitri Leonidovich Romanowsky improved on this technique in the 1890s, using a mixture of eosin and aged methylene blue to produce a wide range of hues not present when either of the stains was used alone.

The first techniques for measuring hemoglobin were devised in the late 19th century, and involved visual comparisons of the colour of diluted blood against a known standard. The first machine that could count blood cells was invented by Wallace Coulter, an American engineer, in 1953. His machine used the principle of electrical impedance, which means that the resistance of a fluid changes when a particle passes through a small aperture.

Hematology Analyzers History

Hematology Analyzer, also known as Blood Cell Analyzer or Blood Cell Counter, is mainly used for testing blood specimens. This instrument can qualitatively and quantitatively analyze the blood components and provide relevant information.

Since the early 1950s, when Mr. Coulter invented the patent for particle counting technology and manufactured the first hematology analyzer for clinical use, hematology analyzers have been in development for more than 60 years. A hematology analyzer is essentially an instrument that analyzes the number and heterogeneity of blood cells in a given volume.

The original blood counters were only able to count red blood cells (RED) and white blood cells (WBC). Later, several parameters such as hemoglobin (HBG), platelets (PLT), red blood cell pressure (HCT), and mean red blood cell volume (MCV) were added.

After the development of Hematology Analyzer, many more parameters have been added for analysis and calculation. Such as Red Blood Cell Volume Distribution Width (RDW), Mean Platelet Volume (MPV), Platelet Volume Distribution Width (PDW), Platelet Pressure Volume (PCT), Large Platelet Ratio, Leukocyte Triplet, Leukocyte Quintuplet, Hemoglobin Concentration Distribution Width, Abnormal Lymphocyte Indication, Infantile Cell Indication, etc. Various parameters and features are constantly being added to some brands of instruments.

Hematology Analyzers Principles

This principle has become the most classic principle in blood cell counting and analysis. The basic meaning of the coulter principle is: a micro-pore is placed in the liquid to be measured, and electrodes of a certain voltage are added at each end of the micro-pore. When the particles in the liquid pass through the micropore, the resistance between the electrodes will produce an instantaneous change. As a result, an electrical pulse is generated. The number of particles can be obtained by counting this electrical pulse. The size of the pulse amplitude indicates the size of the particle volume. By selecting the electrons of the size of the pulses generated by each cell, the different types of cells can be distinguished. By adding a certain amount of negative pressure to the liquid, the liquid passing through the micropores can be made to flow. With the application of various high-tech technologies such as electronics, flow cytometry, laser technology, electronic computer technology and new fluorescent chemicals in clinical testing. This has taken the Hematology analyzers are no longer limited to performing routine blood cell analysis. Many additional features have been added to this instrument. For example, the ability to

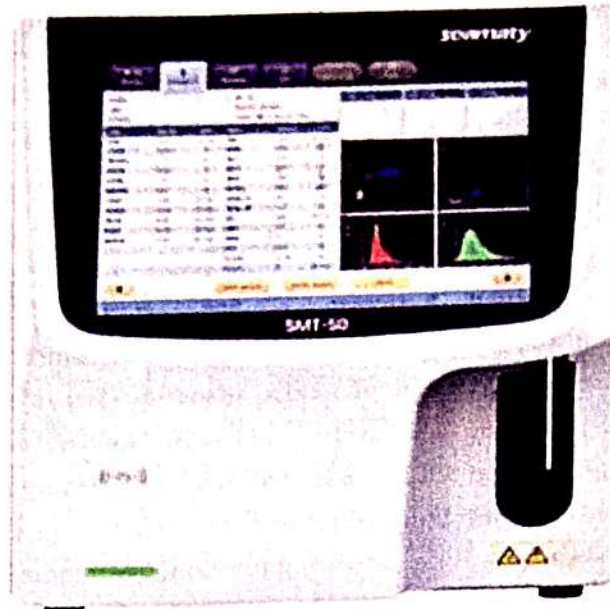


Fig :- Hematology Device

count and analyze reticulocytes (RET) has been added. Some instruments have additionally added naïve cell analysis and nucleated red blood cell analysis. Some hematology analyzers even provide indication of certain parasites in blood cell

CBC Machine works

They work by passing a small amount of blood through a narrow channel. As the blood cells pass through the channel, they are hit by light from a laser. This alters the path of the cells, and sensors detect how far they have been deflected. The machine then uses this information to calculate the number of red and white blood cells in the sample. CBC machines are extremely accurate and can provide essential information about a person's health.

Precautions of CBC machine

A CBC machine is a medical device that is used to count the number of red and white blood cells in a person's body. The machine uses a process called cytometry to measure the cells. The machine can also be used to measure the level of hemoglobin in the blood. A CBC machine is a very precise device, but it is important to take some precautions when using it. First, always wear

gloves when handling the machine. Second, be sure to clean the machine after each use. Third, never reuse needles or syringes. Fourth, never touch the needle tip or anything that has come into contact with the needle tip. Fifth, always follow the manufacturer's instructions for use. By taking these precautions, you can help to ensure that the CBC machine is used safely and effectively.

Benefits of using CBC machine

The CBC machine is a common medical device used to count the number of red and white blood cells in a blood sample. While the device is primarily used to diagnose conditions such as anemia and leukemia, it can also provide important information about a person's overall health. For instance, a high white blood cell count can indicate that the body is fighting an infection, while a low count may indicate a greater risk for developing infections. In addition, the CBC machine can also measure other important blood components, such as platelets and hemoglobin. As a result, the CBC machine is a valuable tool for both diagnosing and monitoring many different medical conditions.

CBC Machine Measures

Measuring changes in your blood cell levels can help your doctor evaluate your overall health and detect disorders. The test measures the three basic types of blood cells.

Red blood cells

Red blood cells carry oxygen throughout your body and remove carbon dioxide. A CBC measures two components of your red blood cells:

RBC count :- Is the total number of RBCs in your blood sample.

Hemoglobin:- Measure the of oxygen-carrying protein that found inside in the RBC.

Hematocrit:- Measures the proportion of your total blood volume that consists of RBCs.

Low levels of hemoglobin and hematocrit are often signs of anemia, a condition that occurs when blood is deficient in iron.

White blood cells

White blood cells help your body fight infection. A CBC measures the number and types of white blood cells in your body. Any abnormal increases or decreases in the number or types of

white blood cells could be a sign of infection, inflammation, or cancer. Different types of wbc's neutrophils, lymphocytes, monocytes eosinophils and basophils.

Platelets

Platelets also called as thrombocytes, it help your blood clot and control bleeding. When a cut stops bleeding, it's because platelets are doing their job. Any changes in platelet levels can put you at risk for excessive bleeding and can be a sign of a serious medical condition.

Hemoglobin (Hb or Hgb)

This is the protein in your blood that holds oxygen.

Hematocrit (Hct)

This test tells how much of your blood is made up of red blood cells. A low score may be a sign that you don't have enough iron, the mineral that helps your body make red blood cells. A high score could mean you're dehydrated or have another condition.

Mean corpuscular volume (MCV)

This is the average size of your red blood cells. If they're bigger than usual, your MCV will be higher. That could happen if you have low vitamin B12 or folate levels. If your red blood cells are smaller, you could have a type of anemia.

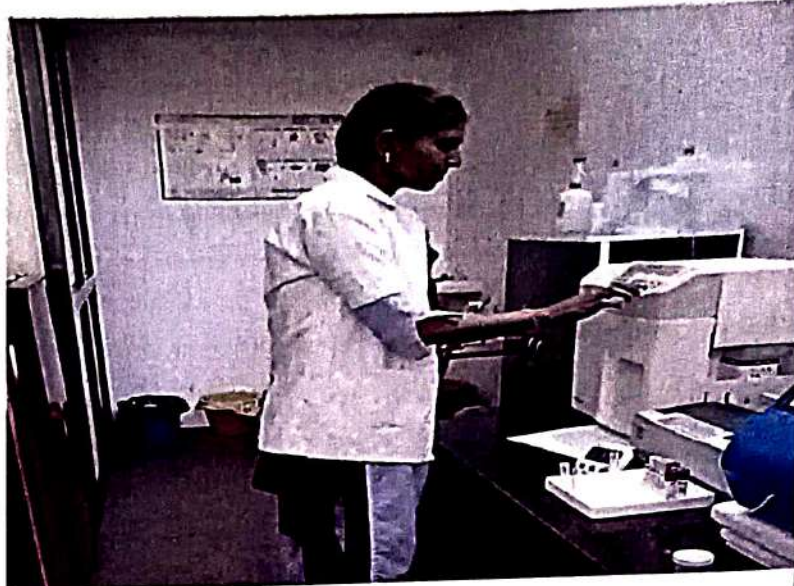
CBC Order

Evaluate your overall health :- Many doctors will order a CBC so they can have a baseline view of your health. A CBC also helps your doctor screen for any health problems.

Diagnose a health problem :- Your doctor may order a CBC if you have unexplained symptoms like weakness, tiredness, fever, redness, swelling, bruising, or bleeding.

Monitor a health problem :- Your doctor may regularly order CBCs to monitor your condition if you have been diagnosed with a disorder that affects blood cell counts.

Monitor your treatment :- Certain medical treatments can affect your blood cell counts and may require regular CBCs. Your doctor can evaluate how well your treatment is working based on your CBC.

Aim: Collection of blood samples

Introduction:

The collection of the blood sample is called phlebotomy and the person who collects the Blood from the patient by technique is called phlebotomist. In MMC sample collection was done in Reception. Phlebotomists collected the blood specimens from patients. Specimens were taken by Phlebotomist in central accessioning area where they were processed, logged into the computer and Given a specimen number and then distributed to the departments for the testing.

TYPES OF SAMPLES:

1. Aseptic fluid
2. Amniotic fluid
3. Serum
4. Plasma
5. Urine
6. CSF

Prepare study procedure equipment:

1. Inspected the integrity of equipment.
2. Syringe.
3. Butterfly set, largest bore suitable for patient's veins.
4. Vacutainer holder.
5. Labelled vacutainer tubes per protocol.
6. Alcohol swabs.
7. Clean gloves. 8. Tourniquet.

Procedure

A: Before initiation of phlebotomy for purpose of blood sampling

1. Checked for signed, dated approved consent form, signed physician's orders, and Completed inclusion/exclusion criteria form.
2. As certain the patient's ID, name, date of birth.
3. Explain procedure to patient.
4. Used hand sanitizer to free hands from any type of contamination.
5. Preparation of study procedure equipment is done.

INITIATION OF PHLEBOTOMY

1. Assess the condition of the patient's veins by palpation concentrate on the anti-cubit

Veins:

- A. Applied tourniquet up intended IV site.
 - B. Tie tourniquet in such a way to allow release with one hand.
2. Preparation of the insertion site:
 - A. Cleansed skin by cleaning with alcohol swab using aseptic technique Starting from centre of proposed site and in a circular motion away From site for 30 seconds.
 - B. Do not touch the prepped area with your fingers. If palpable R reassessment of the vein needs to be done, re-prep the skin prior to Venipuncture.
 3. Anchor the vein by holding patient's arm and placing a thumb below the vein puncture site.
 4. Ask patient to form a fist so the veins are more prominent.
 5. Enter the vein swiftly at a 30 degree angle or less, and continue to introduce the Needle along the vein at easiest angle of entry.
 6. Once sufficient blood has been collected, release the tourniquet before withdrawing the needle.
 7. Withdraw the needle gently and apply gentle pressure to the site with a clean gauze or dry cotton- wall boll.

Following specimens were unable for testing:

1. Labelled was uncompleted (name, age, gender, date, time of collection)
2. Blood specimen haemolyzed.
3. Anticoagulated blood becomes clot by lack of mixing after collection.
4. Specimen delivered to the lab out of specified time after collection.
5. Specimen not stored properly until the time of testing.
6. Specimen collected in anticoagulant have not proper blood anticoagulant ratio.

Hematology

Aim :- CBC Complete Blood Count Test.

Requirements :- Antiseptic wipe, Elastic band, Needle, Tube EDTA and Sodium Fluoride.

Introduction :- The complete blood count (CBC) test is one of the most commonly ordered blood tests. To understand this test, it is important to know that blood consists of two major parts: plasma and cellular elements. The plasma is the part of the blood that is liquid which allows the blood to flow easily. The other part of the blood consists of blood cells.

The major cells in the blood are white blood cells (WBC), red blood cells (RBC), and platelets. Each of these types of cells carries out specific and important functions. The complete blood count test measures the quantity of all the different types of cells in the blood. It also provides some valuable information on other parameters related to each type of blood cell.

Principles :- Hematology analyzers or CBC machine differentiate leukocytes using light-scatter technique and count blood cells via volumetric impedance (Coulter Principle).

Vital for blood cell counts, leukocyte classification, and hemoglobin determination, these analyzers are widely used in healthcare settings like clinics, labs, and physician offices for CBC screenings.

Procedure :-

1. Cleans your skin with an antiseptic wipe.
2. Places an elastic band, or tourniquet, around your upper arm to help the vein swell with blood.
3. Inserts a needle in the your and collects a blood sample in one or more vials.
4. Removes the elastic band.
5. Covers the area with a bandage to stop any bleeding.
6. Label your sample and send it to a lab for analysis.

A blood test can be slightly uncomfortable. When the needle punctures your skin, you might feel a prick or pinching sensation. Some people also feel faint or light-headed when they see blood. Afterwards, you may have minor bruising, but it will clear up within a few days.

Most CBC results are available within a few hours to a day after testing.

Result :- Test results will vary based on your blood cell counts. Here are the normal results for adults, but different labs may deliver slight variations.

A CBC is not a definitive diagnostic test. Blood cell counts that are too high or too low could signal a wide variety of conditions. Specialized tests are needed to diagnose a specific condition. Conditions that could cause an abnormal CBC and may require additional testing include.

- Iron or other vitamin and mineral deficiencies
- Bleeding disorders
- Heart disease
- Autoimmune disorders
- Bone marrow problems
- Cancer

If your CBC shows abnormal levels, your doctor may order another blood test to confirm results. They may also order other tests to help further evaluate your condition and confirm a diagnosis.



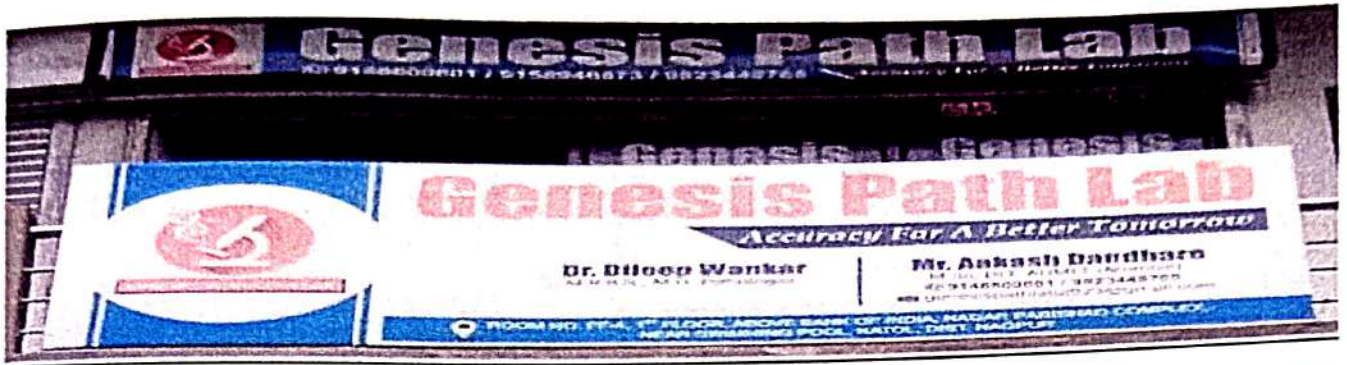



GUT REGION OF THREE SPOT GOURAMI, *TRICHOPODUS TRICHOPTERUS* (PALLAS, 1770): MORPHOLOGY, HISTOLOGY AND HISTOCHEMISTRY

ABSTRACT

Present investigation was undertaken to study the gut region of *Trichopodus trichopterus*. It is an important species in the field of aquaculture and aquarium. Adult specimens of *Trichopodus trichopterus*, commonly called as three-spot gourami were employed for histological and histochemical studies. The findings revealed distinctive intestinal structure characterized by elongated coils and prominent mucosal folds which indicated its herbivorous nature. Goblet cells within the epithelial layer exhibited positive staining for both acidic and neutral mucins. The overall results obtained during present study are important with respect to the dietary and nutritional habits of this aquatic animal

Introduction:

Histological study of animal intestines reveals key insights into digestive function and gut health. In recent years, the variability in teleost gastrointestinal tracts, especially regarding diet diversity, has drawn significant attention as it is influenced by various feeding habits (Abdullahi, 2005). Fish digestive tract consists of an elongated hollow tube, playing an important role in digestion, absorption, and the transport of vital nutrients to various organs (Ray and Ringo, 2014; Kirschbaum and Formicki, 2020). In this context, the information on histological features of the digestive tract of three spot gourami, *Trichopodus trichopterus* seem to be lacking. Therefore, it has been studied and described in present communication, which is probably the first attempt in understanding anatomical features of this fish.

Materials and Method:

Fifteen adult *T. trichopterus*, of both sexes, were collected and acclimated in a

laboratory. Those were daily fed with commercial food and dried worms *ad libitum*. The experiments were conducted in accordance with the guidelines outlined by Committee for the Purpose of Control and Supervision of Experiments on Animals (CPCSEA), New Delhi. Adult fishes with of average length of 7.55 ± 0.18 cm in and 7.70 ± 0.44 g weight, were anesthetized and sacrificed using 0.2% solution of 2-Phenoxy ethanol. Their body length and weight were recorded. The gut portions were then removed, and the lengths of the intestines were measured. Based on these measurements, the relative length of gut (RLG) was calculated as the ratio of full unstretched gut length to the total length of the fish (Al Hussaini, 1949). Zihler index (ZI) was represented as the relation between gut length and ten times the cube root of body mass as: $Zihler\ Index\ (ZI) = \text{gut length (mm)} \times [10 \times (\text{body mass (g)}^{1/3}) - 1]$ (Zihler, 1981). Morphometric analysis, including measurements of intestinal diameter, wall thickness, lumen diameter, and the height and width of mucosal folds, was performed on stained sections using an Image
